Section II: Information to Consultants

Introduction

- 2.1.1 The National AIDS Control Council will select the Consultants among those submitting the proposals or those who respond to the invitation for proposals in accordance with the method of selection detailed under this section and consistent with the regulations.
- 2.1.2 The Consultants are invited to submit a technical proposal and a financial proposal for consulting services required for the assignment stated in the letter of invitation (Section I)
- 2.1.3 In the assignment where the procuring entity intends to apply standard conditions of engagement and scales of fees for professional services, which scale of fees, will have been approved by a relevant authority, a technical proposal only may be invited and submitted by the Independent Reviewer. In such a case the highest ranked individual Consulting individuals in the technical proposals shall be invited to negotiate a contract on the basis of the set scale of fees. The technical proposals will be the basis for contract negotiations and ultimately for a signed contract with the selected individual.
- 2.1.4 The Consultants must familiarize themselves with local conditions as regards the assignment and take them into account in preparing their proposals. To obtain adequate information on the assignment and on the local conditions, Consulting individuals are encouraged to liaise with the procuring entity regarding any information that they may require before submitting a proposal.
- 2.1.5 The client will provide the inputs and services specified in the special conditions of contract needed to assist the Independent Reviewer and Support Consultants to carry out the assignment.
- 2.1.6 The cost of preparing the proposal and negotiating the contract including any visit to the procuring entity are not reimbursable as a direct cost of the assignment. The procuring entity is not bound to accept any of the proposals submitted.
- 2.1.7 The procuring entity's employees, committee members, board members and their relative (spouse and children) are not eligible to participate in the tender.

Clarification and amendment to the RFP documents

- 2.2.1 The individual may request clarification of any of the RFP documents not later than Three (3) days before the deadline for the submission of the proposals. Any request for clarification must be sent in writing by post, fax or email to the procuring entity's address indicated in the special conditions of contract. The procuring entity will respond by post, fax or email to such requests and will send written copies of the response (including an explanation of the query but without identifying the source of inquiry) to all individual Consulting Consultants invited to submit proposals.

- 2.2.2 At any time before the deadline for submission of the proposals, the procuring entity may for any reason; either at its own initiative or in response to a clarification requested by an intended Consultants amends the RFP. Any amendment shall be issued in writing, fax or email to all invited individual Consulting individuals and will be binding on them. The procuring entity may at its discretion extend the deadline for the submission of the proposals.
- 2.2.3 Clarification of tenders shall be requested by the tenderer to be received by the procuring entity not later than 3 days prior to the deadline for submission of tenders.
- 2.2.4 The procuring entity shall reply to and clarifications sought by the tenderer within 1 day of receiving the request to enable the tenderer to make timely submission of its tender.

Preparation of proposals

- 2.3.1 The individuals' proposal shall be written in English language.
- 2.3.2 In preparing the Technical proposal, the individuals are expected to examine the documents consisting the RFP in detail. Material deficiencies in providing the information requested may result in rejection of a proposal.
- 2.3.3 While preparing the Technical proposal, the individual must give particular attention to the following:
- (a) If an Independent Reviewer considers that he/she does not have all the expertise required for the assignment he/she may suggest in the proposals other individual(s) who will assist in the assignment but they will not be party to the contract for the purpose of the performance of the assignment. Consultants will not propose other individuals invited to submit proposals for the assignment. Any Consultants in contravention of this requirement shall automatically be disqualified.
 - (b) For all the staff who will be involved in the exercise of the proposals to individuals must indicate their responsibility in the assignment and also the staff time as necessary.
 - (c) The curriculum vitae (CV) of the staff proposed must be submitted with the proposal.
- 2.3.4 The Technical proposal shall provide the following information;
- (a) The Consultants-a brief of any recent experience of assignment of a similar nature. For each assignment the brief should indicate the profiles of staff involved, contract amount and the **Independent Reviewer** involvement.
 - (b) Any comments or suggestions on the Terms of Reference and a list of service and facilities requested to be provided by the procuring entity.
 - (c) A description of the methodology and work plan for performing the proposed assignment.
 - (d) Any additional information requested in the special conditions of contract.

2.3.5 The Technical proposal shall be separate from the financial proposal and shall not include any financial information.

2.4 Financial proposal

2.4.1 In preparing the financial proposal, the Consultants are expected to take into account the time required in completing the assignment as outlined in the RFP documents. The financial proposal will therefore be quoted in fees per day or month. The financial proposal may also include other costs as necessary, which will be considered as reimbursable.

2.4.2 The Financial proposal should include the payable taxes.

2.4.3 The fees shall be expressed in Kenya Shillings.

2.4.4 The Financial proposal must remain valid for 120 days after the submission date. During this period the Independent Reviewer is expected to keep available at his own cost any staff proposed for the assignment. The Procuring Entity will make best efforts to complete negotiations within this period. If the procuring entity wishes to extend the validity period of the proposals, the Consultants who do not agree, have the right not to extend the validity of their proposals.

2.4.5 The financial proposal must comply with the law governing the profession of the Consultants.

2.4.6 Submission, Receipt and opening of proposals

2.5.1 The Technical Proposal and the Financial Proposal (if required) shall be prepared in indelible ink. It shall contain no interlineations or overwriting, except as necessary to correct errors made by the Independent Reviewer. Any such corrections must be initialed by the Independent Reviewer.

2.5.2 For each proposal the Consultants shall prepare the proposals in the number of copies indicated in the special conditions of contract. Each Technical Proposal and Financial Proposal shall be marked "ORIGINAL" or "COPY" as appropriate. If there are any discrepancies between the original and the copies of the proposal, the original shall govern.

The original and all copies of the Technical Proposal shall be placed in a sealed envelope clearly marked "**TECHNICAL PROPOSAL**", and the original and all copies of the Financial Proposal in a sealed envelope duly marked "**FINANCIAL PROPOSAL**". Both envelopes shall be placed in an outer envelope and sealed. This outer envelope shall bear the Procuring Entities address and other information indicated in the appendix to the instructions to Consultants and clearly marked "DO NOT OPEN before **November 27 2017 at 10.00 am.**" The Proposal submission address is:

2.5.3 The completed Technical and Financial Proposals must be delivered at the submission address on or before the time and date of the submission of the proposals indicated in the appendix to the instructions to Consulting Independent Reviewer. Any proposals received later than the closing date for submission of proposals shall be rejected and returned to the Independent Reviewer unopened. For this purpose the inner envelope containing the technical and financial proposals will bear the address of the Independent Reviewer / Support Consultants submitting the proposals.

2.5.4 After the deadline for submission of proposals the outer envelope and the Technical Proposals shall be opened immediately by the opening committee. The Financial Proposals shall be marked with the Consultants number allocated at the time of opening the outer envelope and the technical proposals but shall remain sealed and in the custody of a responsible officer of the procuring entity up to the time set for opening them.

2.6 Evaluation of the Proposal (General)

2.6.1 From the time the proposals are opened to the time of the contract award, if any individual Consultants wishes to contact the procuring entity on any matter relating to his/her proposal, he/ she should do so in writing at the address indicated in the appendix to the instructions to Consultants. Any effort by Consultants to influence the procuring entity's staff in the evaluation of proposals companion proposals or awards of contract may result in the rejection of the Independent Reviewer and Support Consultants proposal.

2.6.2 The proposal evaluation committee shall have no access to the Financial Proposal, which in any case will remain sealed, until the technical evaluation is concluded or finalized.

Evaluation of Technical Proposals

- 2.6.3 The evaluation committee appointed by the procuring entity to evaluate the proposals shall carry out the evaluation of technical proposals following the criteria set out in the terms of reference based on the following points criteria

CRITERIA	POINTS
(i) Specific experience of the Consultant relevant to the assignment	30
(ii) Adequacy and quality of the proposed methodology, work plan in responding to the Terms of Reference.	30
(iii) Key Experts qualifications and competence for the assignment	40
(a) General qualification, general education, training in the respective field	
(b) Adequacy for the assignment- experience in similar assignments with specific interest.	

NB: Minimum score 70

- 2.6.4 Any proposal which will be examined and found not to comply with all the requirements for submission of the proposals will be declared non responsive. All the proposals found to have complied with all the requirements for submission of proposal shall be declared responsive by the evaluation committee
- 2.6.5 Each responsive proposal will be given a technical score (ST). Any Technical Proposal which fails to achieve the total minimum score indicated in the appendix to the information to tenderers shall be rejected at this stage and will not proceed to the next stage of evaluation. The respective Financial Proposal will be returned to the Independent Reviewer / Support Consultants unopened.

2.8 Opening and Evaluation of Financial Proposals

- 2.8.1 After completion of the evaluation of Technical Proposals the procuring entity shall notify the Consultants whose proposal did not meet the minimum technical score or were declared non responsive to the RFP and terms of reference. The notification will indicate that their Financial Proposals shall not be opened and will be returned to them un-opened after the completion of the selection process and contract award. At the same time, the procuring entity shall simultaneously notify the Consultants who has secured the minimum technical score that they have passed the technical qualifications and inform them the date and time set by the procuring entity for opening their Financial Proposal. They will also be invited to attend the opening ceremony if they wish to do so.

- 2.8.2 The Financial Proposals shall be opened by the Procuring Entity in the presence of the Consultants who choose to attend the opening. The name of the Independent Reviewer, the technical score and the proposed fees shall be read out aloud and recorded. The envelope containing the Quality Cost Based Selection sum per category will also be opened together with the financial proposals of the proposal meeting the minimum technical score. The Tender Opening Committee shall prepare minutes of the opening of the Financial Proposals.
- 2.8.3 The formulae for determining the financial score (SF) unless an alternative formula is indicated in the appendix to the information to tenderers shall be as follows:

$$Sf = 100 \times fm/f \text{ where}$$

Sf is the financial score
 Fm is the lowest fees quoted and
 F is the fees of the proposal under consideration.

The lowest fees quoted will be allocated the maximum score of 20

- 2.8.4 The Consultants proposals will be ranked according to their combined technical score (st) and financial score (sf) using the weights indicated in the appendix to the instructions to Consultants. Unless otherwise stated in the appendix to the instructions to Consultants the formula for the combined scores shall be as follows;

$$S = ST \times T\% + SF \times P\%$$

Where

S, is the total combined scores of technical and financial scores

St is the technical score

Sf is the financial score

T is the weight given to the technical proposal and

P is the weight given to the financial proposal

Note P + T will be equal to 100%

The Consultants achieving the highest Combined Technical and Financial Score under the Quality and Cost Based Selection method will be invited for negotiations.

Negotiations

- 2.9.1 Negotiations will be held at the same address indicated in the appendix to the information to Consultants. The purpose of the negotiations is for the procuring entity and the Independent Reviewer to reach agreements on all points regarding the assignment and sign a contract.
- 2.9.2 The negotiations will include a discussion on the Technical Proposals, the proposed methodology and work plan, staff and any suggestions made by the Independent Reviewer to improve the Terms of reference. The agreed work plan and Terms of reference will be incorporated in the description of the service or assignment and form part of the contract.
- 2.9.3 The negotiations will be concluded with a review of the draft contract. If negotiations fail, the procuring entity will invite the Independent Reviewer whose proposal achieved the second highest score to negotiate a contract.

Award of Contract

- 2.9.4 The contract will be awarded after commencement of negotiations. After negotiations are completed the procuring entity will promptly notify the other Consultants that they were unsuccessful and return the Financial Proposals of the Consultants who did not pass technical evaluation.
- 2.9.5 The selected Consultants are expected to commence the assignment on the date indicated in the appendix to the information to Consultants or any other date agreed with the procuring entity.

Confidentiality

- 2.11.1 Information relating to evaluation of proposals and recommendations of contract award shall not be disclosed to the Consultants who submitted the proposal or to other persons not officially concerned with the process, until the winning individual Consultants has been notified that he/she has been awarded the contract.

TERMS OF REFERENCE

TERMS OF REFERENCE FOR THE INDEPENDENT REVIEWER FOR KENYA AIDS STRATEGIC FRAMEWORK (KASF) 2014/15-2018/19 MID – TERM REVIEW

Introduction

The National AIDS Control Council (NACC) together with Partners and Stakeholders at all levels is planning to conduct the Mid – Term Review (MTR) of the Kenya AIDS Strategic Framework (KASF) 2014/15-2018/19. The detailed background, Purpose and Objectives of the MTR are contained in the Concept Note for MTR. The NACC intends to engage the services of a competent Independent Reviewer to conduct the MTR. The Concept Note on MTR provides details of the entire process.

Objectives of the MTR

The objectives of Mid-Term Review of the KASF are to:

- i) Assess the progress made towards achievement of the stated objectives and targets set out for each Strategic Direction of the KASF, identify strategic and programmatic gaps and make recommendations on the specific strategies needed to address these gaps.
- ii) Identify and document the key factors that either facilitate or impede achievement of targeted results and make recommendations for either corrective action (in case of negative factors) or scaling up (for positive factors).
- iii) To assess the potential impact of major emerging issues and new evidence and knowledge and propose the adjustments needed in strengthening the HIV response for Kenya.
- iv) Assess the progress made by the key structures and institutions charged with facilitating implementation of KASF as part of the delivery infrastructure and make recommendations.
- v) Review the functionality and effectiveness of M&E Framework and make recommendations on strengthening the National M & E for HIV.
- vi) Hold Joint reviews at the Counties to assess the programs implemented with involvement of Implementing Partners

The expected outputs include a Consolidated and Comprehensive MTR report of key findings and recommendations covering each of the strategic directions and result areas of the KASF by Strategic Direction (SD). The report will have:

- i) A status report on each strategic direction and key indicator, with specific recommendations on how to address any observed strategic and programmatic gaps.
- ii) A status report on KASF delivery infrastructure and monitoring mechanisms with recommendations on how to strengthen effectiveness and efficiency.
- iii) A status report on key factors that have facilitated progress under each Strategic Direction
- iv) A status report on key factors that have impeded progress under each Strategic Direction
- v) A status report on implementation of County AIDS Strategic Plans (CASPs), emerging issues and priorities for the next two years and role of key implementing partners by county

Scope of Work and Methodology

The Independent Reviewer will work closely with the Technical Review Team (TRT) and KASF Committees and facilitate conducting of desk reviews, application of Standard Review Protocol and Tools, data collection, analysis and validation for the entire MTR process in line with the approved

Concept Note. The Independent Reviewer will be expected to facilitate and guide the Technical Review Team in generating Draft Thematic Report based on the data collected and the standard templates provided. The Independent Reviewers will then consolidate the Draft Thematic Reports into one Consolidated MTR Report of findings and recommendations.

The Independent Reviewer will be expected to carry out the following tasks;

- Development and submission of the Inception Report
- Facilitation of the KASF Committees/TWG meetings/stakeholder meetings at both county and national levels
- Data/Information gathering through desk review, meetings and interviews.
- Making presentations to the various management structures (Steering Committee, NACC Management, NACC Board) and Key stakeholders
- Development and submission of the MTR reports as outlined in the summary of MTR process, activities and deliverables.

Deliverables

This assignment has clear deliverables that are expected which include the following:

- Inception Report for the KASF MTR process.
- Draft Consolidated and comprehensive MTR report of key findings and recommendations covering each of the eight strategic directions and result areas of the KASF organized by Strategic Direction (SD) (hard copy and soft copy in MS Word). The report will have;
 - A section providing status report on each of the key interventions and recommended actions at MTR per Strategic Direction.
 - A section on key factors that have facilitated progress under each Strategic Direction and best practices.
 - A section on emerging issues and the recommended strategies proposed for improvement.
 - A section on key factors that have impeded progress under each Strategic Direction and recommended strategies.
 - A section on the effectiveness and relevance of KASF delivery infrastructure and monitoring mechanisms.
 - A report on the entire review process will also be developed.

The report will also have an Annex on programme/CASP implementation by County and priorities for the next two years.

Final Consolidated and comprehensive MTR report of key findings and recommendations (hard copy and soft copy in MS Word).

The report should be written with the following qualities being taken into account;

1. It should be factual: Every report should be based on facts, verified information and valid proofs. The information sources should be documented.
2. Clear, Easily understandable, Concise and reader friendly.
3. Free from grammatical and typographical errors.
4. Recommendations should be objective and relevant

Timelines

This Technical Assistance is a 50 working days assignment spread out between October 2017 and Mid December 2017. The Independent Reviewer will be expected to work closely with the Technical Review Team (TRT) to generate a detailed Workplan indicating the specific assignments for members of the Technical Review Team (TRT) based on the scope of work. The Independent Reviewer will be expected to be available throughout the process.

Responsibility and Administration

The Independent Reviewers will be responsible to Chief Executive Officer -NACC through the Deputy Director- Policy Monitoring and Research; while the day - to - day operations will be handled through the Head, Policy and Strategy.

Cost and Payment

The cost should indicate clearly all the cost elements which will be involved. All prices should be quoted in Kenya Shillings. Payments will be based on approved deliverables as follows:

- Inception Report: 5%
- Draft MTR Report and documentation of MTR Process: 45%
- Final MTR Report and final documentation of MTR Process: 50%

Copyright and ownership of all deliverables

All the information generated, compiled and developed under this assignment will remain the property of NACC. This includes data gathering tools, raw data and all reports. Submission of the Proposals

Potential Independent Reviewers should submit separate Technical and Financial Proposals. Qualifications and Capacity of the Independent Reviewer

The Independent Reviewer is expected to have high level of skills and experience at National and International level in Development and Review of Country and Regional HIV and AIDS Strategic Frameworks/Plans. At least three (3) references should be provided

Academic Qualifications

Advanced degree (Masters) in Health or Social Sciences, Public Health, Health Research, Epidemiology, Policy analysis, Healthcare Financing/Economics, Project Management, Governance and Strategic Information, or related field with specific qualifications in the field of Monitoring and Evaluation.

Experience

- A minimum of Fifteen (15) years of relevant experience at National and International Level in Development and Review of Country and Regional HIV and AIDS Strategic Frameworks/Plans and a focus on the following areas; Prevention, Treatment and Care, Health and Community systems strengthening, Strategic Information and Monitoring and Evaluation, Research, Healthcare Financing, Governance, leadership and accountability; including at least five (5) years of professional experience in Monitoring and Evaluation. Specific experience working in Kenya and the East African Region is required.
- Undertaken at least four (4) similar assignments at national and/or international level in the last 3 years, verified through review of past work experience (references of at least 3 clients to be provided).
- Demonstrated an understanding of HIV Programme Performance Indicators, Analysis in the context of HIV and Health Financing, Macroeconomic Analysis and Expenditure Reviews.
